$\frac{\textbf{MOTION TO QUASH AND FOR PROTECTIVE ORDER REGARDING SUBPOENA}}{\textbf{OF EXPERT}}$

The Little Neck Legal Action Committee ("LNLAC"), a non-party to this action, hereby moves pursuant to Mass. R. Civ. P. 45(b)(1) to quash the subpoenas which Defendants served on the Keeper of Records of Peterson LaChance Regan Pino, LLC and the Keeper of Records of Petersen LaChance Realty Advisors (collectively, "Peterson LaChance"), and on Mr. William LaChance ("Mr. LaChance").
