## 1 DIRECT EXAMINATION

2

- 3 Q (By Mr. Sheehan) Good evening.
- 4 A Hello.
- 5 Q Would you tell us what your full name is, and spell your
- 6 last name for the record?
- 7 A Laura Hunter Dietz, D-I-E-T-Z.
- 8 Q And where do you live?
- 9 A 9 Bush Hill Road, Ipswich, Mass.
- 10 Q And how long have you lived there?
- 11 A Eighteen years.
- 12 Q And your educational background, please, starting with
- high school?
- 14 A I went to Cornwall Central High School in Cornwall, New
- York; and Wells College in Aurora, New York where I got a
- Bachelor's; and Suffolk Law School for my J.D.
- 17 Q And when did you receive your J.D.?
- 18 A 1991.
- 19 Q And are you licensed to practice law in the Commonwealth
- of Massachusetts?
- 21 A I am.
- 22 Q Have you been so licensed since 1991?
- 23 A Yes.
- 24 Q And do you practice law?

- 1 A I do.
- 2 Q Okay. And would you tell me about your practice of law
- 3 presently?
- 4 A I am assistant general counsel at the Mass. Department of
- 5 Conservation and Recreation. And there I do a lot of
- 6 policy work; a lot of work with propopsed legislation.
- 7 I do a little bit of real estate, not much.
- and a lot of contract work. More sort of a general prac-
- 9 tice shop.
- 10 Q And how long have you worked for the D.C.R.?
- 11 A Three and three quarter years.
- 12 Q You've just told me what the Mass. D.C.R. does at least
- 13 what you do there?
- 14 A Mmm-hmm.
- 15 Q Okay. And give me an overview of what the Mass. D.C.R.
- does, what it consists of, what jurisdiction it has and
- 17 so on?
- 18 A Mass. D.C.R. is an agency of maybe twelve hundred or so
- employees which grows to over two thousand in the summer.
- We're basically the state parks agency.
- We also are the former M.D.C., so we own and
- 22 control Storrow Drive and a lot of ice skating rinks,
- swimming pools, state forests, state parks. And dams, we
- 24 have jurisdiction over all dams of a certain size.

- 1 So it's a very varied agency.
- 2 Q Does the Massachusetts D.C.R. have any jurisdiction over
- 3 Little Neck, Ipswich, Massachusetts?
- 4 A No.
- 5 Q Does the Mass. D.C.R. have any jurisdiction over Crane's
- 6 Beach?
- 7 A No.
- 8 Q And prior to going to work for the Mass. D.C.R., can you
- give me your occupational history, please?
- 10 A For the nine years immediately prior to working for the
- D.C.R. I was a free-lance legal writer. I wrote for
- 12 AMJUR mostly; CJS, a lot of legal encyclopedias and state
- jurisprudences. I still do a little bit of that.
- 14 Q What subject matters have you written on?
- 15 A Oh, my goodness. Many, many dozens. I would not even
- 16 remember them. Oh, insurance. Eminent domain I think
- was the first thing I ever wrote about. Oh, my gosh.
- 18 Civil service; public employees; torts.
- 19 There's so many, I really can't even -- just an
- enormous amount. Many dozens of different topics.
- 21 Q And who was it that determined that you would write on a
- 22 particular topic or topics?
- 23 A The editorial the sort of head editor at Thompson which
- 24 became West, which is now Thompson Reuters.

- 1 Q All right.
- 2 A So they don't look for anybody with particular expertise
- in an area. You don't need to have -- you just need to
- be a lawyer. But you don't -- so basically, you need to
- 5 know how to research.
- 6 But you don't need to have expertise. These
- 7 are for national jurisprudences, so the coverage is
- 8 pretty wide.
- 9 Q All right. And prior to doing that legal writing, what
- 10 did you do?
- 11 A I worked for -- and I was the comptroller and for a short
- time general counsel at Boston Financial and Equity
- Corporation. That was from 1985 till I don't know, '99.
- 14 No, maybe '96.
- 15 And then I practiced at an environmental law
- firm which was Wright, Moehrke and then it was Moehrke,
- Mackie and Shea. And now, it's -- what are they, Mackie
- 18 -- I don't even know what they're called now.
- Anyway, they're in the Back Bay.
- 20 Q In Boston?
- 21 A Mmm-hmm.
- 22 Q Okay. And was that your first legal position with the
- 23 environmental law firm?
- 24 A Mmm-hmm.

- 1 Q You have to answer yes or no for us?
- 2 A Oh, yes.
- 3 Q Thank you.
- 4 A Yes.
- 5 Q All right. And how long were you with the environmental
- 6 law firm?
- 7 A I worked for them part-time only from probably 1992 until
- 8 '94, and then again -- let's say '95 till '99, approxi-
- 9 mately.
- 10 Q And while you were working with the environmental law
- firm, what kinds of matters did you get involved in,
- 12 personally?
- 13 A Well, I was originally hired to help manage a large cost
- 14 recovery action.
- 15 Q And tell us what that is?
- 16 A It was largely a 21 E case where our -- let's see, how
- did this work? We were trying to -- let's see.
- There was an old oil pit essentially in Waltham
- which we were trying to get, oh, it had to be over a
- 20 hundred potentially responsible parties to pony up and
- clean up. And it had been dumped in for seventy five
- years from federal agencies, the armed forces to private
- companies.
- 24 Q Were you representing the property owner?

- 1 A Yes.
- 2 Q Other than that one case, did you have other matters on
- 3 which you worked?
- 4 A I did. I did some corporate -- and it was a large solid
- waste client base, so I did a lot of their corporate
- 6 work, you know; their minutes, sort of clerk-type duties.
- 7 And I -- what else did I do for them? I would
- 8 -- oh, I did some insurance work for them, though not
- 9 much.
- 10 That's really all I can remember at the moment.
- 11 Q All right. And what year did you receive your B.A. from
- 12 Wells College?
- 13 A 1985.
- 14 Q What was the business of Boston Financial and Equity?
- 15 A That was a very interesting company. They still exist,
- actually. And the president of the company basically
- developed -- headed up the second hand computer leasing
- business. He was extremely well-known in that small
- 19 industry.
- And so basically, we leased computer equipment
- 21 to high risk clients, including folks like the Sports
- 22 Authority and people who couldn't get leases to rent a
- computer and they couldn't buy computer equipment any-
- 24 where else, we would lease them stuff.

- 1 So Sports Authority started with our equipment.
- What became AOL started with our equipment.
- 3 So it was a pretty interesting niche business.
- I don't think anybody else did it but us.
- 5 Q And when you say high risk, what do you mean?
- 6 A They were usually start-ups or they were turn-aroundd
- 7 companies. They might have just come out of bankruptcy.
- 8 They might be in Chapter 11 bankruptcy.
- 9 And nobody would lend them money or equipment
- 10 but us.
- 11 Q Now, with respect to the cost recovery case ----
- 12 A Mmm-hmm.
- 13 Q ---- that you talked about in Waltham?
- 14 A Mmm-hmm.
- 15 Q Was that in suit?
- 16 A I'm trying to remember where it was when I left. Let me
- actually -- you know, I don't even remember. I honestly
- don't remember where it was at when I left; if we had
- actually filed or it we were still just talking to PRPs.
- I really don't remember.
- 21 Q Now, have you engaged in the area of civil litigation?
- 22 A No.
- 23 Q Have you been in a courtroom?
- 24 A Mmm-hmm.

- 1 Q What kinds of work have you done in a courtroom?
- 2 A I've done one thing in a courtroom, other than be on a
- jury for an insurance case. It was to get a temporary
- 4 restraining order to freeze a client's bank account that
- 5 owed us money.
- 6 Q That owes your company money?
- 7 A They owed the firm money.
- 8 Q Now, have you ever served on a board or a committee in
- 9 the Town of Ipswich?
- 10 A Yes.
- 11 Q And would you tell me about that, please?
- 12 A Well, I currently serve on the Ipswich School Committee.
- I was elected in May of 2009. I've served on -- oh, I
- served on a local non-profit board.
- 15 0 What is that?
- 16 A That is Cuvilly Arts and Ford Center. It's a pre-school
- organic farm kind of interesting place. My daughter went
- 18 to school there. And I was the chair of the board for
- 19 six years.
- 20 Q Could you spell that for us, please?
- 21 A Cuvilly is C-U-V-I-L-L-Y.
- 22 Q What else?
- 23 A I was appointed by the selectmen to the -- oh, what was
- it called, the commission on energy use and climate

- 1 protection, where I served for probably three years while
- we did a greenhouse gas inventory. And ultimately, they
- 3 came up with a climate action plan, though I was off by
- 4 then.
- 5 Q All right.
- 6 A I was also appointed by the selectmen to serve on the
- 7 government study committee, which I also served on for
- 8 approximately three years.
- 9 Q Was that a local government study?
- 10 A Yes.
- 11 Q Did the climate action plan work involve in any way the
- feoffees of the grammar school in the Town of Ipswich?
- 13 A Not to my knowledge.
- 14 Q Did the local government study committee have anything to
- do with the feoffees of the grammar school in the Town of
- 16 Ipswich?
- 17 A No.
- 18 Q Any other boards or committees or organizations in the
- Town of Ipswich on which you now serve or have served?
- 20 A Not that I can think of. I don't believe so.
- 21 Q When you ran for school committee and leading up to the
- 22 election of May of 2009, was it a contested election?
- 23 A No.
- 24 Q Okay. And how many seats were open in May of -- for the

- 1 election in May of 2009?
- 2 A There were two seats open.
- 3 Q Okay. And you were a candidate and there was one other
- 4 candidate?
- 5 A Yes.
- 6 0 Who was that?
- 7 A That was Hugh O'Flynn.
- 8 Q Have you heard of the feoffees of the grammar school in
- 9 the Town of Ipswich?
- 10 A I have.
- 11 Q When did you first hear of them?
- 12 A I cannot recall. I really have no idea.
- 13 Q Did you know of them as of May of 2009?
- 14 A Yes.
- 15 Q And what did you understand the feoffees were as of May
- 16 of 2009?
- 17 A To the best of my recollection, at that time I understood
- they were trustees.
- 19 Q And did you understand who the beneficiary was?
- 20 A Yes.
- 21 0 Who was that?
- 22 A The Ipswich schools, generally. And so I consider it the
- 23 Ipswich School Department.
- 24 Q Do the feoffees own any real estate?

- 1 A Yes.
- 2 Q What do they own?
- 3 A They own Little Neck.
- 4 Q When did you first learn that the feoffees owned Little
- 5 Neck?
- 6 A I don't recall when I first learned that.
- 7 Q Did you -- so you say you lived at your -- you lived in
- 8 your present location in Ipswich for eighteen years?
- 9 A Mmm-hmm.
- 10 Q Did you live in Ipswich before that?
- 11 A No.
- 12 Q So you've been an Ipswich resident for eighteen years?
- 13 A Yes.
- 14 Q Okay. And you've been on the school committee since May
- 15 of 2009?
- 16 A Mmm-hmm.
- 17 Q You have to answer yes or no for us?
- 18 A Yes. I'm sorry.
- 19 Q And fair to say that some time between eighteen years ago
- and May of 2009 that you heard for the first time about
- 21 the feoffees?
- 22 A Yes.
- 23 Q Have you ever served on any committee or organizations in
- the Town of Ipswich dealing with the feoffees other than

- the Ipswich School Committee?
- 2 A No.
- 3 Q Okay. Now, when you ran for election in May of 2009, did
- 4 you understand that there was litigation to which the
- 5 feoffees were a party?
- 6 A Yes.
- 7 Q What did you understand about that litigation as of May
- 8 of 2009?
- 9 A Specifically, at that time I'm not sure. I'm not sure
- what I understood. I really don't know specifically, you
- 11 know, for May of '09.
- 12 Q Why did you run for school committee?
- 13 A In general, I believe in public education. I think it
- should be supported. Folks had asked me for a long time
- to run, and I always said no, I was too busy.
- And I just decided the time was right, so I
- 17 ran.
- 18 Q Do you have children in the Ipswich public schools?
- 19 A I do.
- 20 Q Could you give me their names and ages, please?
- 21 A I have a daughter, and her name is Madeleine, and she's
- 22 sixteen.
- 23 Q Were you influenced to run for the school committee in
- 24 May of 2009 by reason of any issues pertaining to the

- 1 feoffees?
- 2 A Probably.
- 3 Q Tell me what about the feoffees inspired you to run?
- 4 A It would have been one factor in my decision to run. And
- 5 it was a desire to A, understand a little more closely
- 6 what exactly what was happening with the feoffees; and B,
- 7 to try to see the situation resolved through that under-
- 8 standing.
- 9 Q And what, if anything, did you do prior to your election
- in May of 2009 to understand the issues that involved the
- 11 feoffees?
- 12 A I don't recall.
- 13 Q Did you do anything prior to the election in May of 2009
- to see feoffees issues resolved?
- 15 A No.
- 16 Q Now, what did you do after May of 2009 to understand the
- issues that involved the feoffees?
- 18 A Basically, I gained a better understanding of issues per-
- 19 taining to the feoffees through attendance at school
- 20 committee meetings.
- 21 Q Did you review documents of any kind so as to understand
- 22 better feoffee related issues?
- 23 A Yes.
- 24 Q What documents did you review?

- 1 A The one document I can remember viewing would have been
- the draft trust that I know had gone back and forth
- 3 between the school committee and the feoffees for some
- 4 time, and I don't know how much time prior to my looking
- 5 at it.
- 6 Q And is that the document that proposed to re-organize the
- 7 feoffees?
- 8 A I believe that was [art of it.
- 9 Q What other documents, if any, did you review in order to
- 10 understand feoffee related issues?
- 11 A I can't recall.
- 12 Q Did you seek to understand issues that were raised in the
- superior court litigation involving the feoffees?
- 14 A Only in a very general way.
- 15 Q What did you do?
- 16 A I just asked questions of people who I thought might
- understand what exactly that litigation was about.
- 18 Q Who did you ask questions of?
- 19 A Jeff Loeb.
- 20 Q Anyone else?
- 21 A I don't believe so. I don't recall.
- 22 Q Now, Attorney Loeb was not acting as your counsel when
- you were asking him those questions?
- 24 A No.

- 1 Q Tell me what you asked of Jeff Loeb and what he said in
- 2 response?
- 3 A I honestly don't remember exactly what I asked him. I
- 4 recall that I asked him just generally what was the
- 5 superior court litigation about.
- 6 His response was it was a rent strike and it
- 7 was rent litigation.
- 8 Q Did he say anything else?
- 9 A Not that I remember.
- 10 Q And have you ever seen the complaint that was filed by
- unhappy tenants against the feoffees in the superior
- 12 court?
- 13 A I don't recall. I may have, but I don't remember speci-
- 14 fically.
- 15 Q Let me show you a copy of the complaint?
- 16 A Mmm-hmm.
- 17 Q I think this one is without all of the exhibits, but just
- to see if that refreshes your memory at whether or not
- 19 you've seen it?
- 20 A You know, I honestly -- I don't remember. I really don't
- 21 know if I've seen it before or not.
- 22 Q Have you seen the answer and counter-claim filed by the
- feoffees in the superior court case?
- 24 A I don't recall.

- 1 Q Did you inquire of Attorney Loeb as to what he thought of
- 2 the merits or lack of merits of either the complaint or
- 3 the answer and counter-claim as filed by the unhappy
- 4 tenants and the feoffees?
- 5 A I don't believe I did.
- 6 Q Have you ever attempted to make any analysis of the like-
- 7 lihood of success or lack thereof of any of the claims of
- any of the parties in the superior court case?
- 9 A No.
- 10 Q And you've not asked anyone for their opinion as to the
- merits or lack thereof of any of the claims in the
- 12 superior court case?
- 13 A Not that I can recall.
- 14 Q Now, are there any other documents that you can recall
- reviewing so as to better understand feoffees issues,
- other than the draft trust?
- 17 A I -- not that I recall.
- 18 Q And have you reviewed the complaint filed -- the amended
- complaint filed by the feoffees in the probate court?
- 20 A Yes.
- 21 Q When did you first review that?
- 22 A It would have been soon after it was filed, which was
- December of '09, right? January 10th or -- soon after it
- was filed. I don't remember the date.

- 1 Q And for what purpose did you review the complaint?
- 2 A I reviewed it because the school committee was a named
- defendant, and I thought it would be prudent.
- 4 Q Okay. And did you engage separate counsel; that is,
- 5 separate from the firm of Casner & Edwards, to review
- 6 that complaint?
- 7 A No.
- 8 Q And did you understand the contents of the first amended
- 9 complaint?
- 10 A Yes.
- 11 Q Did you review the answer that was filed by the school
- committee and Superintendent Korb in that complaint?
- 13 A I did at the -- yes, I did.
- 14 Q And have you reviewed other pleasdings, either discovery
- pleadings or other non-discovery pleadings, that have
- been filed or served in the probate court case?
- 17 A Yes.
- 18 Q And what have you reviewed?
- 19 A I've reviewed everything that's been forwarded to me as a
- school committee member. So -- and honestly, I don't
- remember what specific documents those are. I've seen
- answers to discovery. I've seen discovery both ways.
- I don't even remember what else.
- 24 Q Have you reviewed any deposition transcripts of folks who

- were deposed in the probate court case?
- 2 A No.
- 3 Q Have you reviewed any deposition transcripts of folks who
- 4 were deposed in the superior court case?
- 5 A No.
- 6 Q Do you recal receiving a copy of a response to a request
- for admissions, the response being filed in behalf of the
- 8 Ipswich School Committee?
- 9 A I don't recall.
- 10 Q At some point in time did you review minutes of meetings
- of the Ipswich School Committee with respect to meetings
- that were held wherein the subject of the sale of Little
- 13 Neck was discussed?
- 14 A Not -- only in the context of reviewing minutes prior to
- a meeting at which we would vote to accept them or not.
- 16 Q All right.
- 17 A Not -- not other than that.
- 18 Q Now, tell me about the process by which minutes are
- 19 reviewed and approved by the Ipswich School Committee?
- 20 A Minutes are sent to the school committee with an agenda
- and a packet of any other materials that are going to be
- 22 discussed at the subsequent -- at the next meeting.
- What I do is I review everything in the packet,
- including the minutes, and prepare to vote or discuss,

- 1 you know, at that following meeting.
- 2 Q And fair to say that you take seriously your obligatin to
- 3 review minutes for accuracy before you approve them?
- 4 A Mmm-hmm. Yes.
- 5 Q You have to answer -- okay.
- 6 A Yes.
- 7 Q First, without showing you a document, do you remember an
- 8 Ipswich School Committee meeting on December 2, 2010
- 9 wherein there was discussed the feoffees probate court
- 10 litigation?
- 11 A That specific meeting, no, I don't.
- 12 Q Now, let me show you that document and ask you if that
- 13 refreshes your recollection as to a meeting on February -
- I'm sorry, December 2, 2010 at which the probate court
- 15 litigation was discussed?
- 16 A Yeah. Yeah. I mean, yes.
- 17 Q Fair to say that the document I've just given to you is a
- true and accurate copy of minutes of an Ipswich School
- Committee meeting held in open session on December 2,
- 20 2010?
- 21 A I have no reason to think otherwise.
- 22 Q And these minutes were reviewed by you and presumably
- other school committee members, and they were ultimately
- 24 approved?

- 1 A I believe so. I don't know. I mean, I assume that these
- would be approved minutes.
- MR. SHEEHAN: Now, could we have that document
- 4 marked, please, Bill, as Exhibit Number One?
- 5 MS. BREWER: And Bill, we've been writing --
- 6 this will be Dietz Exhibit Number One.
- 7 MR. SHEEHAN: yes.

- 9 (Exhibit Number One marked; Copy of 12/2/10 Ipswich
- 10 School Committee Minutes)

- 12 Q Now, when you ran for election in May of 2009, did you
- understand that the school committee had prior to May of
- 14 2009 voted in favor of a sale of Little Neck?
- MS. BREWER: Objection.
- 16 A Yes.
- 17 Q And did you understand that the sale -- the proposed sale
- 18 price was twenty six and a half milion dollars?
- 19 A I'm not sure that I knew the price.
- 20 Q Prior to your election in May of 2009, did you have an
- opinion as to whether Little Neck should be sold?
- MS. BREWER: Objection.
- 23 A I don't recall. I don't think so.
- 24 Q Now, at some time the vote of November 20, 2008 at which

- the school committee voted to sell Little Neck or approve
- 2 the sale of Little Neck for twenty six and a half million
- dollars, that vote was re-visited, wasn't it?
- 4 MS. BREWER: Objection.
- 5 A What was the beginning of the question?
- 6 Q Yes. Are you familiar with the November 20, 2008 vote of
- 7 the Ipswich School Committee regarding sale?
- 8 A I don't know -- no, I'm not.
- 9 Q All right. Let me show you what was marked as Korb
- 10 Number Eight?
- 11 A Mmm-hmm.
- 12 Q Have you ever had occasion to review the minutes of the
- meeting of the Ipswich School Committee on November 20,
- 14 2008?
- 15 A No.
- 16 Q At any time did you learn of a vote that was made by the
- 17 Ipswich School Committee based on a motion of Dr. O'Flynn
- and seconded by Mr. Sheppard to go forward with the sale
- of Little Neck property authorized by the feoffees to the
- tenants at the price of twenty six and a half million
- 21 dollars?
- 22 A I was aware that there was a vote, and I don't know if it
- 23 was then or not, that the school committee had taken
- prior to my joining the school committee at which they

- voted to -- in favor of a sale at some certain price.
- 2 Q In the context of your trying to learn about feoffee
- 3 related issues?
- 4 A Mmm-hmm.
- 5 Q Did you ever seek to review minutes of meetings of the
- 6 school committee regarding the sale of Little Neck?
- 7 A No.
- 8 Q And do you remember a meeting of the school committee on
- 9 November 19, 2009 at which the issue of the sale of
- 10 Little Neck was discussed?
- 11 A No, not specifically.
- 12 Q Now, let me show you what has been marked as Korb Number
- 13 Twenty Eight?
- 14 A Mmm-hmm.
- 15 Q And ask you if that refreshes your memory about a meeting
- that was held on November 19, 2009?
- And I may have said 2008, and if I did I apolo-
- 18 gize. Minutes of a meeting of November 19, 2009 at which
- 19 was discussed the issue of the sale of Little Neck?
- 20 A I do recall this meeting in general terms.
- 21 Q And tell me what you remember happening on that day?
- 22 A Well, as reflected in the minutes, I actually do remember
- 23 the MCAS presentation.
- Now, is your question more specific about the

- feoffees or just the whole meeting?
- 2 Q Yes. Specifically, with respect to the subject matter
- described as item number seven under Roman numeral II on
- 4 page 3 of what has previously been marked as Korb Number
- 5 Twenty Eight ----
- 6 A Mmm-hmm.
- 7 Q ---- on the feoffees sub-committee?
- 8 Do you see that?
- 9 A Yes.
- 10 Q And does that refresh your memory as to a vote taken on
- 11 November 19, 2009?
- 12 A Yes.
- 13 Q Okay. And tell me what happened in connection with that
- 14 vote?
- 15 A I don't remember the exact conversation that the school
- 16 committee had. I do remember that it was -- we discussed
- the school committee's position with regard to a prior
- offer of sale which they had previously voted to accept,
- 19 I quess voted in favor of.
- 20 And there was a motion made to rescind that
- 21 approval vote. I declined to vote at all. I abstained
- 22 because I wasn't on the school committee when they took
- the original vote and I didn't think it was appropriate.
- 24 Q You didn't thik it was proper for you to vote?

- 1 A Yes. I didn't think I really had a place in rescinding
- an approval for something I hadn't been involved in the
- 3 beginning.
- 4 Q Now, fair to say that that motion to rescind was made at
- 5 the request of the Finance Committee of the Twon of
- 6 Ipswich?
- 7 MS. BREWER: Objection.
- 8 A No.
- 9 Q Now, let me show you what's been marked as Loeb Number
- 10 Five?
- 11 A Mmm-hmm.
- 12 Q Have you seen that document before?
- 13 A I don't recall. I really don't remember.
- 14 Q Now, who is Jamie Faye?
- 15 A Jamie Faye is a current member of the Ipswich Finance
- 16 Committee.
- 17 Q Okay. And on October 15, 2009, he was the chairman of
- 18 the finance committee.
- 19 Is that right?
- 20 A I'm not sure.
- 21 Q Well, according to this document it would purport to be
- that he was the chairman?
- 23 A That would not be surprising. Yes. He's been the chair-
- 24 man, so.

- 1 Q Have you ever -- strike that.
- Prior to October 15, 2009, had you ever had
- 3 conversation with Jamie Faye about the sale of Little
- 4 Neck?
- 5 A No.
- 6 Q Prior to October 15, 2009, had you ever had any conver-
- 7 sation with any sitting member of the finance committee
- 8 regarding the sale of Little Neck?
- 9 A Not that I recall.
- 10 Q Did you receive a copy of the document that we've marked
- 11 as Loeb Number Five?
- 12 A I don't recall.
- 13 Q As best you can remember, this is the first time you've
- 14 seen that document?
- 15 A As best I can remember. I mean, it does cc the school
- 16 committee. So presumably, perhaps I got a copy. But I
- 17 really don't remember it.
- 18 Q All right. Let me show you what's been marked as Loeb
- 19 Number Three?
- 20 A Mmm-hmm.
- 21 Q Have you seen that document before tonight?
- 22 A Not that I recall. It's possible, but I don't remember
- 23 specifically.
- 24 Q Do you see at the top of the -- on the header ----

- 1 A Mmm-hmm.
- Q ---- of this what appears to be an e-mail that there's a
- 3 cc to the school committee?
- 4 A Mmm-hmm. Yes.
- 5 Q Did you typically receive -- strike that.
- 6 Who would typically receive in behalf of the
- 7 school committee such an e-mail?
- 8 A Presumably, it would be the entire school committee. And
- 9 there have been instances where their e-mail addresses
- 10 are incorrect and -- you know?
- But I have no reason to think that I did not
- 12 receive this. It is quite likely that I received this,
- 13 yes.
- 14 Q Do you recall how you received it? Did you receive it
- 15 electronically?
- 16 A If I received it, it would have been electronically, yes.
- 17 Q Did you receive it directly from Mr. Faye?
- 18 A Presumably, yes.
- 19 Q Now, had you ever spoken to Jamie Faye about the sale of
- 20 Little Neck on or before November 17, 2009?
- 21 A Not that I recall.
- 22 Q And had you discussed the sale of Little Neck with any
- 23 sitting member of the finance committee prior to November
- 24 -- prior to or on November 17, 2009?

- 1 A Not that I recall.
- Q When you received Loeb Number Three, ----
- 3 A Mmm-hmm.
- 4 Q ---- did you see that it was -- that among the recipients
- were the Ipswich Chronicle, the North Shore Weekly at the
- 6 Boston Globe, and the Salem News?
- 7 MS. BREWER: Objection.
- 8 A I see that now. I don't recall -- you know, because I
- 9 don't recall having seen this in 2009 I can't say what I
- 10 noticed in 2009. But I see it now.
- 11 Q Do you know of any reason that Mr. Faye would send a copy
- of this e-mail to the Ipswich Chronicle or the Salem News
- or the Boston Globe or a combination thereof?
- MS. BREWER: Objection.
- 15 A I would have no idea.
- 16 Q And is it your testimony that before tonight you didn't
- notice that Mr. Faye had copied those newspapers on his
- 18 e-mail?
- MS. BREWER: Objection.
- 20 A It's my testimony that I don't recall the e-mail at all,
- so I don't recall having noticed anything in particular
- 22 about it.
- 23 Q Fair enough. Now, did you vote on November 19, 2009 on
- 24 the sale of Little Neck?

- 1 A I don't recall.
- 2 Q And do you have before you Korb Number Twenty Eight?
- 3 A Mmm-hmm. Yes, I do.
- 4 Q Okay. And at that time the matter came before the school
- 5 committee, and you determined that you should abstain
- 6 because you had not voted on the matter in November of
- 7 2008?
- 8 A That is correct. I had not voted, yes, ----
- 9 Q All right.
- 10 A ---- in the previous -- yes.
- 11 Q As of November 19, 2009, did you have an opinion one way
- or the other as to whether or not Little Neck should be
- sold by the feoffees?
- MS. BREWER: Objection.
- 15 A No, I don't think I did.
- 16 Q Had you looked into the issue of the sale of Little Neck
- 17 as of November 19, 2009?
- 18 A I guess I -- I mean, honestly, I don't remember specific-
- 19 ally.
- 20 Q At any time prior to November 19, 2009, had you tried to
- 21 determine the pros and cons of such a sale?
- 22 A I don't recall.
- 23 Q Do you recall having any conversations with any fellow
- school committee members on or prior to November 19, 2009

- discussing the potential pros and cons of selling Little
- 2 Neck?
- 3 A I don't recall. And I doubt it.
- 4 Q Now, let me show you what's been marked as Loeb Number
- 5 Seven?
- 6 A Mmm-hmm.
- 7 Q Have you ever seen this memorandum before?
- 8 A Yes.
- 9 Q And when did you first see the memorandum?
- 10 A I don't recall the exact date. I would imagine it was
- some time in the spring of 2010.
- 12 Q Did you vote as part of the school committee to create an
- ad hoc committee to look into the question of the settle-
- ment agreement between the feoffees and the Little Neck
- 15 Legal Action Committee?
- 16 A I actually don't recall if we voted to create the ad hoc
- 17 committee or if the chair at the time created the ad hoc
- 18 committee and told us about it.
- I don't -- I don't recall.
- 20 Q Do you know why the ad hoc committee was created?
- 21 A I do.
- 22 O What was that?
- 23 A It was created to help us understand the financial impli-
- cations of the settlement agreement between the feoffees

- 1 and the tenants.
- 2 Q And fair to say that one of the charges of the ad hoc
- 3 committee was to determine whether the settlement agree-
- 4 ment was economically feasible?
- 5 MS. BREWER: Objection.
- 6 A I -- that would probably be one way to put it.
- 7 Q That's the way the ad hoc committee put it, isn't it?
- 8 A Okay.
- 9 Q Do you see that on economic feasibility?
- 10 A Oh, there we go. Yeah. Yes.
- 11 Q Yes. And fair to say that the ad hoc committee deter-
- mined that it was -- that the settlement agreement was
- economically feasible?
- MS. BREWER: Objection.
- 15 A That's not my recollection.
- 16 Q Okay. What do you recall was the report of the ad hoc
- committee as to the economic feasibility of the settle-
- ment agreement?
- 19 A Well, I could sit here and read it and tell you exactly
- what they said in the report.
- 21 What I recall is that there were many condi-
- tions that would have to be met in order for it to be
- economically feasible.
- 24 Q And conditions other than those that are described in

- 1 Loeb Number Seven?
- 2 A I do not recall. Probably not.
- 3 Q All right.
- 4 A But I don't recall for sure.
- 5 Q Did you make a determination as to whether or not any of
- those conditions could not be met by the feoffees?
- 7 A I do not -- I don't recall.
- 8 Q As of the date that you received the memorandum -- strike
- 9 that.
- 10 You did receive a copy of the memorandum that
- 11 we've marked as Loeb Number Seven?
- 12 A Yes, I did.
- 13 Q And as of the time that you received that memorandum, had
- 14 you made a determination as to whether or not Little Neck
- should be sold by the feoffees?
- MS. BREWER: Objection.
- 17 A Before I read this memorandum? Is that the question?
- 18 Q Well, we'll ----
- 19 A Or after ----
- 20 Q ---- take it one step at a time?
- 21 A Okay.
- 22 Q How about before you received the memorandum, had you
- 23 made a determination?
- MS. BREWER: Objection.

- 1 A I don't believe I'd made a -- no, I don't think I had.
- 2 Q All right. After reviewing the memorandum, did you make
- a determination as to whether or not Little Neck should
- 4 be sold?
- 5 MS. BREWER: Objection.
- 6 A Well, I did ultimately at some point after reading this,
- and I don't remember exactly when, we took a later vote.
- 8 So I honestly don't remember exactly when I made up my
- 9 mind.
- 10 Q Let me show you what's been marked as Loeb Number Two?
- 11 A Mmm-hmm.
- 12 Q And do you recognize Loeb Number Two as being a portion
- of minutes of a meeting of the Ipswich School Committee
- in executive session on November 18, 2010?
- 15 A I do.
- 16 Q Do the minutes of November 18, 2010 marked as Loeb Number
- 17 Two accurately report what transpired at that executive
- 18 session?
- 19 A To the best of my recollection, yes.
- 20 Q And at that time there was a vote on whether or not to
- 21 accept the twenty nine million, one hundred fifty thou-
- 22 sand dollar price set forth in the settlement agreement
- between the feoffees and the tenants; correct?
- 24 A That's correct.

- 1 Q And you voted on that issue?
- 2 A I did.
- 3 Q Now, prior to that vote, did you read the settlement
- 4 agreement?
- 5 A Yes.
- 6 Q When did you first receive the settlement agreement?
- 7 A I don't recall the date. It was -- I believe it was the
- day that you came to a school committee meeting we were
- 9 holding in the Performing Arts Center and presented it to
- 10 us.
- 11 So perhaps we'd received it a little earlier in
- the day or -- I don't remember. It was around that time,
- 13 yes.
- 14 Q A presentation was made about that settlement agreement
- in January of 2010?
- 16 A 2010, that sounds about right.
- 17 Q And William Sheehan spoke at that meeting?
- 18 A Yes.
- 19 Q As did William Gottlieb and Mark DeSalvo?
- 20 A Yes.
- 21 Q And you understood that Mr. Gottlieb and Mr. DeSalvo were
- 22 members of the Little Neck Legal Action Committee?
- 23 A Yes.
- 24 Q Okay. And you understood that Mr. Sheehan was at that

- time representing the feoffees?
- 2 A Yes.
- 3 Q And at that meeting you had an opportunity, as did all
- 4 school committee members, to ask any questions that you
- had about the settlement agreement?
- 6 A Yes.
- 7 Q And fair to say that Mr. Sheehan, Mr. Gottlieb and Mr.
- B DeSalvo attempted to explain the elements of that settle-
- 9 ment agreement?
- 10 A They attempted to explain at least some of the elements
- of the settlement agreement.
- 12 Q And that was a meeting that was held in open session?
- 13 A Yes.
- 14 Q And in fact, it was moved out of the normal arena where
- the school committee meets and moved into the Performing
- 16 Arts Auditorium?
- 17 A Yes.
- 18 Q And so members of the public were there?
- 19 A Yes.
- 20 Q And the members of the public had an opportunity to ask
- 21 questions about the settlement agreement?
- 22 A I don't recall. I would imagine they did, but I don't
- 23 recall specifically.
- 24 Q And did you go through that settlement agreement page by

- 1 page?
- 2 A I believe I did. If I did it was once. So I wouldn't
- 3 remember a lot of specifics about it, but I did read
- 4 through it once.
- 5 Q Was there anything in the settlement agreement that you
- 6 did not understand?
- 7 A To my recollection, I think there were a number of things
- 8 I didn't understand.
- 9 Q All right.
- 10 A I had questions about that -- some of the financing spe-
- cifics, which is why the ad hoc committee was appointed
- or formed to help us, myself included, understand some of
- those provisions.
- 14 Q Did the ad hoc committee answer all of your questions?
- 15 A I believe they did.
- 16 Q And so fair to say that as of November 18, 2010 you had
- 17 reviewed the settlement agreement, and any questions you
- had had been answered by the ad hoc committee?
- 19 A Yes.
- 20 Q Now, you voted against the -- accepting the twenty nine
- 21 million, one hundred fifty thousand dollar price?
- 22 A That's correct.
- 23 Q Why?
- MS. BREWER: Objection.

- 1 A Because at base I don't think Litttle Neck should be
- 2 sold. I think the asset is more valuable. I think the
- 3 trust is more valuable with land as the asset rather than
- 4 cash or some investment vehicle.
- 5 Q And what examination of facts did you undertake to come
- 6 to that conclusion?
- 7 MS. BREWER: Objection.
- 8 A I believe -- you know, I don't -- I can't recall specifi-
- 9 cally. I do recall asking the question of I believe it
- 10 was this ad hoc committee.
- But they weren't prepared to answer it because
- I don't think it was their charge to not only look at
- what the sale would mean in the finish ramifications, but
- what -- would a continuing quentil [phonetic] model, what
- would that look like and would that be a viable option?
- Again, I don't believe that they answered that
- 17 question because they weren't charged with that.
- 18 Q Did anyone answer that question for you prior to November
- 19 18, 2010?
- 20 A Not that I recall.
- 21 Q All right.
- 22 A Yeah, I don't -- I don't recall, actually.
- 23 Q And did you look at any appraisal information prior to
- 24 Noevember 18, 2010?

- 1 A I don't recall the date that I looked at the appraisal
- 2 information. I'd have to see the appraisal to see when
- 3 they were dated. I don't recall the date.
- 4 Q Well, did you look at any appraisal information before
- you voted to reject the twenty nine million, one hundred
- 6 fifty thousand dollars?
- 7 A Honestly, I don't remember when the appraisal -- when the
- 8 two -- I've seen two appraisals and I don't remember when
- 9 they were done. When they were -- I assume it must have
- been before then, but I don't remember.
- 11 Q Who's appraisals did you see?
- 12 A The appraisal by Colliers, Meredith & Grew that the
- finance committee put out an RFP for; and the Licoln
- 14 appraisal from the -- for the school committee.
- 15 Q That was the appraisal of Mr. Foster?
- 16 A Yes.
- 17 Q And did you review the appraisal conducted by Peterson
- 18 LaChance?
- 19 A No.
- 20 Q Did you review the appraisal conducted by LandVest?
- 21 A No.
- 22 Q Now, the Lincoln appraisal was commissioned by the school
- 23 committee, wasn't it?
- 24 A That's correct.

- 1 Q And it was commissioned by the school committee because
- 2 the school committee had no confidence in the Colliers,
- 3 Meredith & Grew appraisal.
- 4 Isn't that right?
- 5 MS. BREWER: Objectin.
- 6 A No, that's not true.
- 7 Q Well, why did you do your -- why did the school committee
- 8 have Lincoln do an appraisal?
- 9 A Honestly, I don't recall the exact reason and the discus-
- sion that led up to us deciding to do that. I really
- 11 don't remember.
- 12 Q Now, do you recall Mr. Foster reporting to the school
- 13 committee that the Colliers, Meredith & Grew number of
- forty two million dollars was not accurate?
- MS. BREWER: Objection.
- 16 A No.
- 17 Q Do you recall Mr. Foster telling the school committee
- 18 that forty two million dollars -- forty two point six
- 19 million dollars is not the right value?
- MS. BREWER: Objection.
- 21 A No, I don't.
- 22 Q Do you recall Mr. Foster telling the school committee
- that taking out the quote, bad, end quote of the tenants;
- that is the threat of litigation, a developer would look

- at it as a twenty point five million dollar value who
- 2 would then sub-divide the lots?
- MS. BREWER: Objection.
- 4 A I don't recall that specifically.
- 5 Q Now, let me show you what's been marked as Korb Exhibit
- 6 Number Twenty Nine?
- 7 A Mmm-hmm.
- 8 Q And does that refresh your memory of a school committee,
- 9 finance committee and board of selectmen meeting that was
- held on November 9, 2010?
- 11 A Yes.
- 12 Q And in particular with respect to that portion of the
- minutes of that -- that's a -- strike that.
- 14 The school committee, finance committee and
- board of selectmen are called the tri-board?
- 16 A Yes.
- 17 Q And what has been marked as Korb Number Twenty Nine are
- minutes of a tri-board meeting of November 9, 2010?
- 19 A That's what they appear to be, yes.
- 20 Q And in particular with respect to the portion of the
- 21 minutes that begins on page 2 towards the bottom ----
- 22 A Mmm-hmm.
- 23 Q ---- under the caption, Foster Appraisal, and continues
- on to page 3?

- 1 A Mmm-hmm.
- 2 Q Do you have any reason to believe that the minutes, that
- portion of the minutes are in any way inaccurate?
- 4 A I have no reason to believe that they're inaccurate.
- 5 Q Now, this information was important to you because you
- 6 understood that on or shortly after November 9, 2010 you
- 7 were going to be asked to vote on the sale of Little
- 8 Neck; correct?
- 9 A Yeah. I didn't know exactly when we would -- I would be
- asked. But I knew that, yes, we would have to vote
- 11 eventually.
- 12 Q And in fact, you voted nine days after this tri-board
- 13 meeting?
- 14 A Yes.
- 15 Q Did you have in mind when you voted on November 18, 2010
- 16 what Mr. Foster had said about value?
- 17 A Did I have it in mind? Sure. I'm sure I remembered what
- he had said. I don't know how it influenced me or not,
- 19 you know, my vote. But ----
- 20 Q Well, what did you do to -- and form your conclusion that
- Little Neck would be more valuable holding on to it and
- 22 renting it as opposed to selling it and creating an
- endowment fund for the benefit of the schools?
- 24 A I honestly don't recall, you know, seeing any data or --

- I don't recall how I came to that conclusion.
- 2 Q As you sit here today, can you support that conclusion?
- MS. BREWER: Objection.
- 4 A I honestly don't know.
- 5 Q Now, other than your belief that the land would be more
- 6 valuable -- strike that -- that Litle Neck would be more
- 7 valuable if you -- with the land as opposed to the cash
- as you put it, any other reason that you voted against
- 9 the settlement agreement?
- 10 A No.
- 11 Q Are you aware of an issue regarding erosion at Little
- 12 Neck?
- 13 A Not specifically. I think it's something that I've heard
- about. And I don't even know where it is at Little Neck,
- 15 so.
- 16 Q I'm sorry?
- 17 A I don't -- I wouldn't know where the erosion is at Little
- 18 Neck. I've heard about something, but nothing specific.
- 19 Q Now, was the issue of erosion something that you had in
- 20 mind when you decided that you would vote against the
- 21 sale?
- MS. BREWER: Objection.
- 23 A I don't believe so.
- 24 Q Have you been to Little Neck?

I think I drove through there years and years ago. 1 2 But not recently? 3 Α No. 4 MR. SHEEHAN: All right. Well, Ms. Dietz, I 5 have no further questions. I want to thank you for 6 coming in here this evening. We started late. And I appreciate your squeezing us in between your work day and 7 8 the -- and I understand you have a school committee 9 meeting tonight. 10 Attorney Brewer now has the opportunity to 11 inquire. 12 THE WITNESS: Okay. 13 MS. BREWER: I have no questions today. 14 THE WITNESS: Okay. 15 (Whereupon, the deposition in the above entitled matter 16 17 was concluded at 5:35 p.m.) 18 19 20 21 22 23
